Terms and conditions of use for MEXMOD

This document sets out the applicable terms and conditions for the use of the information contained in the [microsimulation model for Mexico \(Mexmod\)](#), which is administered by [Centro de Investigación en Alimentación y Desarrollo, A.C. \(CIAD\)](#). The terms and conditions to which the Mexmod user must be subject are as follows:

1. Mr/Ms _____ ('the User') hereby agrees to abide by these terms and conditions, which may be amended without prior notice by El Centro de Investigación en Alimentación y Desarrollo, A.C. (CIAD) from time to time, for the use of the country model MEXMOD for non-commercial research.
2. The User shall acknowledge the use of MEXMOD in any publications and other outputs (such as conference presentations), mentioning the [EUROMOD](#) software version number and the version number of MEXMOD used, as indicated in paragraphs 1 and 2 of the annex.
3. The User shall inform the MEXMOD team at El CIAD de Mexico about the use of the model and about all related publications.
4. The User must not provide the model or any individual country model to any third parties. Potential users should contact the MEXMOD team at El CIAD de Mexico directly.
5. Access to the use of the model is granted on an individual and institutional' basis. If the User changes his/her current employer, institution or organization, this Agreement shall expire automatically. If the User uses the model under a new employer, institution or organization, the User shall inform the MEXMOD team at El CIAD de Mexico accordingly. In this case issuing a new Agreement will be considered.
6. Any research papers using the model shall be submitted to the MEXMOD team at El CIAD de Mexico for consideration of publication in the Regional Development Division, a process that does not restrict the submission of the manuscript to another source of academic dissemination and research.
7. The User shall familiarize him/herself with, and abide by, the conditions of access of the input microdata that the User makes use of (including if specified sharing an electronic copy of research using the model with the data provider: [INEGI](#)) and shall acknowledge use of these data in any publication.
8. The results and their interpretation presented in the resulting publication shall be solely author's/s' responsibility.
9. All rights not expressly granted to The User by El CIAD de Mexico in this Agreement shall be hereby reserved.
10. The User shall compensate El CIAD de Mexico at all times against all or any costs, claims, damages, or expenses incurred by El CIAD de Mexico, with respect to the use of the model by The User.
